The council for the Town of Carrollton met in regular session on Monday, October 3, 2016, at 6:00 p.m., at City Hall, 206 W. Washington, Carrollton, MO 64633.

## **ROLL CALL**

## a. Sharon Metz – Train Stop Update

October 5, 2016 at 10:00 a.m. - Amtrak meeting. Senator Pearce will be in attendance by phone. The Commission and Council have been invited. Rich Rhodes, the MO Rails representative, two representatives from Amtrak will be present. Metz asked Council's approval to hold the meeting in Council Chambers. The Council unanimously approved the request.

## **NEW BUSINESS**

# a. <u>Chris George – Drugs In Community</u>

Chris George stated he felt there was not enough drug enforcement in the Town but it was not the fault of the work of the Police Department. They are too busy and short staffed to spend the time that needs to be on the drug problem. Suggested to the Council to hire an investigator for drugs only. There is the possibility of grant money for this position. Proposed Chief Turner looked into this.

Chief Turner stated they had this position previously but due to under staffing had to use that Officer for regular duty.

# b. Jeff Adams – Edward Jones Retirement Plans

Jeff Adams presented his proposal for retirement plans that would be available that would be funded by America United Life Insurance Company (One America Company).

The plan type offered would be 401(a)/457(b). The service level would be bundled and the investment lineup would be institutional.

Jeff Adams touched on all the variables of investments, costs, employees participating and plans chosen.

Mesirow Financial would be included with the Plan.

# c. Ryan Minnick – State Farm Retirement Renewal

Ryan Minnick stated he was just present for the renewal of the current plan. Minnick stated Municipal Utilities was not a participant of the State Farm Plan but was with Richie Forsythe.

In the current plan the Town matches up to 3% of employee contribution and not out any additional money. The employee absorbs all the fee.

Some employees have a money market fund.

There is no annual maintenance fee.

State Farm only invests in State Farm Mutual Funds.

Counselor Cowherd spoke briefly of Loggers Retirement System that many municipalities are currently enrolled in. The cost is based on the group demographics. The cost to obtain the group demographics would be approximately \$925.

There would be a choice of the level of benefits, also includes back-service. Contribution would be 0-4%. This is not something that could be done this year.
